Provide a copy of the advisory opinion and brief written statement explaining the circumstances.

Category C:

If you do not fall into the one of the following categories, you must submit the documentation described above.

I certify that I am not required to be registered with Selective Service because:

I am a female

I have not reached my 18th birthday.

I was born before 1960.

I am a resident of the Federated States of Micronesia or the Marshall Islands, or a permanent resident of the Trust Territory of the Pacific Islands (Palau).

I am in the Armed Services on active duty. Attach a copy of active duty military I.D.

(NOTE: Does not apply to members of the Reserves and National Guard who are not on active duty.)

I am a noncitizen/citizen who first entered the U.S. after I turned 26. Attach a copy of your I-94, I-551, or I-551C or a copy of your citizen certificate.

I am a noncitizen/citizen who entered the U.S. as lawful nonimmigrant status and remained in the U.S. under the terms of that visa until after age 26. Attach a copy of I-94, I-551, or I-551C or a copy of your citizen certificate.
