ENROLLMENT DEPOSIT REFUND & WAIVER POLICIES

DEFERENTIAL OF ENROLLMENT

UNC Asheville considers requests for Deferral of Enrollment on a case-by-case basis. Students seeking permission to defer their enrollment after admission for either one semester or one year must submit a letter of request that provides the reason for the request, plans for their deferment period, and the requested enrollment term. Students may not enroll in another college or university during their time of deferment without being subject to a new admissions decision based on the student's most recent academic record. If the deferral request is approved, the student must complete an application for readmission and submit a new deposit for their term of enrollment by the appropriate deadlines. If the deferral request is received prior to December 15, 2011, the student deposit will be refunded. If a deferral request is submitted after the December 15, 2011 deadline, the deposit is either forfeited or applied toward the deferred term.
