You must promptly notify the Admissions Office in writing of any criminal charge, any disposition of a criminal charge, or any school, college or university disciplinary action against you, or any type of military discharge other than an honorable discharge that occurs at any time after you submit this application. Your failure to do so will be grounds to deny or withdraw your admissions, or dismiss you after enrollment. Also, students who indicate they have been convicted of a crime will be notified regarding required procedure for obtaining a criminal background check from the UNC system approved vendor.

Application must be signed and dated before we can render an admission decision. An incomplete application will be returned to you for completion, thereby delaying action on your application.
